- 5. ACCOUNTING: No discussion

6. CHIEF'S REPORT (DC Jim Mathias and BC Rob Bartsch):

- A. Effective today, the fire tower lookouts have been downstaffed for the season and open burning is now allowed. Effective next Monday, there will be one engine each at Smartsville and Dobbins CDF stations. Depending on rain, we may enter the Amador Contract with CalFire by late December.
- B. The Sheriff's department is working on a program called Zone Haven for better evacuation information.
- C. A crack was discovered at the water tank at Station #63. Repairs made determined to be satisfactory.
- D. Station #62 has mold on the ceiling—there may be a roof leak, as the roof appears to be very old. Some siding on the back may need to be replaced as well.
- E. Chief Bartsch reported there were 55 calls last month: 31 medical aid, 10 vegetation fires, 5 accidents. The remaining calls were false alarms (unable to locate).
